Lastly, 'The Balipara/Tirap/Sadiya Frontier Tract Jhum Land Regulation (Amendment) Bill, 2024' focuses on revising regulations concerning jhum cultivation lands. This amendment is crucial for addressing land management issues in the frontier tracts, promoting [sustainable agricultural](#) practices, and safeguarding the rights and livelihoods of indigenous communities engaged in jhum cultivation.

These bills collectively represent the state's [commitment to](#)

[legislative reforms and strategic governance](#). Their successful enactment is expected to [pave the way](#) for a more robust, transparent, and inclusive administrative framework in Arunachal Pradesh, aligning with the broader developmental goals outlined by the Governor in his address.
