

# Tripura Government Imposes Restrictions on Vehicle Movement Due to Flood Damage

## Impact of Recent Heavy Rainfall and Flooding

Since August 19, uninterrupted heavy rainfall has wreaked havoc across Tripura, causing extensive damage to infrastructure. The deluge has resulted in river swelling, breaching of embankments, and large-scale flooding, severely impacting both urban and rural areas. Particularly affected are the embankments along the Katakhal and Howrah rivers in the West district, with significant breaches recorded that have resulted in inundation of adjacent areas.
